### IMPORTANT INFORMATION

#### EVISA ELIGIBILITY

The government of Azerbaijan utilises an electronic visa issuance system. The eVisa is an electronic authorisation from the government to enter Azerbaijan. It is the equivalent to a visa, but no stamp or label is placed in your passport. To be eligible the traveller must:

- Hold a passport valid at least six months on entry with one blank visa page
- Hold proof of onward/return flights or hotel reservation
- Hold all documents required for the next destination
- Hold proof of sufficient funds

In order to facilitate this, please complete the Visalink Azerbaijan eVisa Questionnaire included in this pack. All questions must be answered as they are mandatory fields on the Azerbaijan Government website. Once completed, please upload securely at <https://visalink.com.au/upload-forms?service=evisas>

#### VISA VALIDITY

This is a single entry visa which is valid for 3 months from date of issue for a stay of up to 30 days. Travellers who wish to apply for a stay longer than 30 days need to apply for a traditional visa



### COPY OF PASSPORT IDENTIFICATION PAGE

A clear colour copy of your passport or travel document. The file must:

- Be supplied in JPG format
- Be no larger than 1MB in size
- Only include the passport information page

2. Azerbaijan eVisas are valid for 30 days from the date of entry and allow a single entry.

## DECLARATION

Issuance of electronic visas through the ASAN Visa system and their use are carried out under the following terms:

1. Electronic visas are issued only to the citizens of the countries approved by the Ministry of Foreign Affairs of the Republic of Azerbaijan and stateless persons permanently residing in those countries;
2. Persons with dual citizenship have to choose the country in accordance with their passport or other travel document they are going to use for their travel. If the passport or other travel document used to apply for an electronic visa is different from the passport or other travel document used for travel, the electronic visa is considered invalid;
3. Foreigners and stateless persons have to apply for the electronic visa at least 3 working days prior to their arrival in the Republic of Azerbaijan;
4. The period of validity of the passport or other travel document should be at least 3 months longer than the period of validity of the electronic visa planned to be issued;
5. The electronic visa is issued within 3 working days and allows the holder to stay in the country for 30 days;
6. The date of arrival in the Republic of Azerbaijan is determined at least 3 working days after the date of submission of the e-Visa application.
7. Persons applying for an e-Visa are personally responsible for the accuracy of the data entered in the e-Visa application, the scanned page of the passport or other travel document and the correctness of the payment they have made;
8. E-mail addresses of e-visa applicants should be entered correctly. Notifications of the receipt of e-visa applications and payments, including information on the issuance or cancellation of the electronic visa, are sent to the applicant's e-mail address;
9. Electronic visa applications are not accepted if incorrect or incomplete information is entered or payments are made improperly;
10. Issuance of an e-Visa is denied pursuant to Article 16 of the Migration Code of the Republic of Azerbaijan;
11. The ASAN Visa system is not obliged to state the reasons for the refusal to issue an electronic visa;
12. Foreigners and stateless persons may apply for a visa to relevant diplomatic representations of the Republic of Azerbaijan in the event of electronic visa denial;

## PROCESSING TIMES

The fastest processing time available is 1 business days after your application is submitted to the consulate. Remember that consulates can experience delays and may request additional support documents that can lengthen processing times. Processing begins the day after we receive your materials.

## PROCESSING FEES

Fees consist of both Visalink's service fees and consular processing fees. The total price of your order will depend on the services you select, the number of travellers and the number of business days we have to process your order, starting with the day we submit your application. Visalink fees are per application and are exclusive of Consular fees and third party fees. Fees are as follows:
